- 2. Applicant
 - (1) Online nationality certificate application is only applicable to ROC overseas nationals, in which the applicant shall be the concerned person.
 - (2) For minors, the application shall be filed by their legal representative.
- 3. Attached certificates
- (1) For online applications, image files shall be uploaded
 - i. The signed application
 - ii. Valid ROC passport
 - iii. The applicant's full-face half-length color photo taken within the last two years. The photo specification shall be consistent with that of the photo on the national ID card (https://www.ris.gov.tw/app/portal/187).
 - iv. For minors, their legal representative's ID certificate, agreement of Legal representative and the parent-child relationship certificate shall be additionally uploaded.
- (2) Certificates required to be submitted to the Mission Abroad by the applicant in order to pick up the ROC nationality certificate:
 - i. The original of the signed application.
 - ii. The original of the valid ROC passport
 - iii. The photo same as the updated photo image. The photo specification shall be consistent with that of the photo on the national ID card.
 - iv. Certificate fee (US\$45) (the fees may be charged by converting them to the local currency according to the provisions of currency conversion for the charge of consular fees).
 - v. If the application is filed by the legal representative, the legal representative shall submit their ID certificate and the parent-child relationship certificate.
- 4. Steps to apply for ROC nationality certificate on the website of Dept. of Household Registration:
 - (1) On line application
 - i. The applicant shall go online to fill out the application and submit the filled application, followed by printing the application and signing on it.
 - ii. To scan the signed application, passport and photo and upload them to the operation system or directly upload the images taken by the camera to the operation system (images shall be clear and recognizable).
 - iii. After the online submission, the system will provide a set of case No. for the applicant to print as the application receipt for future reference. The applicant can still correct the data and upload the required certificates and documents within 24 hours. However, the National ID No., the name of Mission Abroad where the certificate will be picked up, password and the 1st set of e-mail information are not allowed to revise. Thus, please be careful when filling in the details.
 - iv. The review operation will be initiated 24 hours after the application is submitted. By then, if the filled information are required to revise or there is any doubt about the information, the applicant shall indicate the case No. and

- v. After MOI's review, if the application is required to correct, MOI will notify the applicant by e-mail, whereas the applicant shall make the correction online.

Prior to MOI completing the review of the application (i.e. before MOI notifies any permit, rejection or overruling of the application by e-mail), applicants may withdraw their nationality certificate application online, for which MOI will respond to the applicant about the handling results by e-mail after receiving the applicant's withdrawal application.


Photo Specification Required for 2005 Nationwide Replacement of National ID Cards

The applicant shall submit one full-face, half-length, bareheaded and thin glossy color photo with white background taken in the last two years, in which the applicant shall not wear colored glasses and their eyes, nose, mouth, face, ear contours, special moles, birthmarks, scars, etc. shall be clear without obscuration. The photo shall not be altered and shall be in the size of 4.5 cm in length and 3.5 cm in width making the applicant recognizable. The length of the portrait from the top of head to the lower jaw shall not be smaller than 3.2 cm and over 3.6 cm. Any composite photo is not allowed. Please indicate the applicant's name, national ID number and the date that the photo was taken on the back of the photo. The details required for the photo are as follows: (the photo sample is posted on the website of MOI at https://www.ris.gov.tw)

- 1. The photo shall be taken in the last two years.
- 2. The size of the photo shall be 4.5 cm in length and 3.5 cm in width and a close-up shot shall be taken on the head and top of the shoulders to make the face taking up 70 80% of the photo space.
- 3. The focus shall be clear and distinct and the photo shall be with high quality and without ink smear or creases.
- 4. When taking the photo, the eyes shall directly look to the shot of the camera, the skin tone shall naturally appear, and the brightness and contrast shall be appropriate.
- 5. The image shall be developed (printed) on the high quality photo paper with high resolution.
- 6. If the photo is taken by a digital camera, the image shall be with high color saturation and developed (printed) on photo paper.
- 7. The photo shall be with the neutral color.
- 8. The eyes shall be open and can be clearly seen. They shall not be covered by hair. The contour of the face shall be clearly presented without leaning or facing right/left side (similar to the portrait form). Both sides of the face, the contours of two ears, special moles, birthmarks and scars shall be clearly presented, and the photo shall not be altered. Microtia patients may cover their ear contours with their hair, but the both sides of their face shall still clearly appear without any obscuration.
- 9. The photo shall be taken with white background.
- 10. The light source shall be even without reflection of any shadow or flashlight on the face. Nor shall red eyes are allowed.
- 11. If the applicant wears glasses:
 - (1) The eyes shall be clearly presented without reflection of any flashlight on the glasses. No colored glasses are allowed (however, visually impaired applicants may wear colored glasses).

- (2) To make sure that the frame of the glasses does not cover any part of the eyes (please avoid big and heavy eye glasses frames, instead, please wear light and handy glasses).
- 12. For those who are required to wear turbans/scarfs due to religious reason, the five facial features from the bottom of the jaw to the forehead and the contours of both sides of the face shall be clearly presented.
- 13. The photo shall show the image of the applicant only(the images of chair back, toys or other people shall not appear in the photo). When taking the photo, the eyes shall directly look to the shot of the camera without any special facial expression and the mouth shall be closed.




Notes:

- 1. To avoid affecting photo effects and beauty of the new certificate, it is recommended that the public wear dark color clothes and avoid light color clothes for photo taking.
- 2. Hair tying and dyeing are not restricted. There is no restriction for those who are under chemotherapy or have thin hair due to their personal physical constitution to wear a wig.
- 3. For those who wear long hair, in principle, the bangs shall not cover their eyebrows and any of their five facial features. The hair on the temples shall be part of the hair. If it is too long and apparently covers the ears, it shall be properly trimmed. Nevertheless, the hair shall not deliberately cover the ears. There is no restriction for wearing a beard.
- 4. Earrings and nose rings are not restricted, but the facial features or contours of eyes, nose, mouth, face and two ears shall not be deliberately obscured.
- 5. "No special facial expressions with closing mouth" refer to natural facial expressions without exaggeration, but smile is not restricted.



(shall have their national ID certificate number and IC ATM card issued by a domestic card issuance bank): 3 + 1 + the last nine digits of the national ID No. for a total of 11 digits. Example: If the national ID No. is A123456789, the payment receipt No. shall be 31123456789.

National ID No. (or business registration No.): National ID No. (containing a letter); example: A123456789
