Application reason	ROC nationality has been lost and a foreign nationality has been acquired.
Governing law	1、paragraph 1 of Articles 15, 16 of the Nationality Act. 2、Articles 2, 7, 15, 16, 18 of the Enforcement Rules of the Nationality Act. 3、Charge Standards for Nationality Fees
Competent authorities	The applicant shall apply to their local residence household registration office in person, and the household registration office will transfer the application to MOI via municipal or county (city) government for approval.
Documents required	Documents required to be submitted by the applicant 1、Application form for restoration of nationality (form 7) (1) Applicants shall confirm the correctness of the application printed by the household registration office, followed by signing or affixing their seal on the application. (2) Applicant is the minor, Parents shall sign or affix their seal on the application. In the event that the minor's rights and obligations are individually exercised and assumed by either father or mother, the certificate for individual exercise of the custodial rights shall be submitted, in which the father or mother exercising the custodial rights of the minor shall sign and affix their seal on the application. If there is any guardian, the custody certificate shall be submitted, in which the guardian shall sign on the application. If the number of the guardians is more than one, all of the guardians shall sign or affix their seals on the application. 2、A valid alien resident certificate or alien permanent resident certificate Please apply to the Service Center of National Immigration Agency of MOI at your residence place. Please apply for extension of the residence period within 30 days before the residence period expires. 3、The police criminal record or other related certificate documents issued by the government of the applicant's country of origin (please refer to Remarks 4 for document verification) (1) Apply to the government of the applicant's country of origin. The issuance day shall be within six months prior to the application date. if, after the document being issued by the government of the

applicant's country of origin, the applicant exits for a certain period of time after entry and the competent authority considers it suspicious, the competent authority may request the applicant to turn in their no-crime record certificate for their exit period.

(2) If the applicant is the spouse of a ROC citizen and has already acquired the alien permanent resident certificate or the residence reason stated in their alien resident certificate is "a dependent of relatives (husband or wife)", they are exempted from attaching the certificate. If the applicant is under the age of 14 or entered Taiwan before the age of 14 and has not gone abroad since then, they are exempted from attaching the certificate.

4、The certificate to prove enough property or professional skills for self-support or ensuing living.

(Accumulated value of property includes property and income of the spouse, the spouse's parents, or applicant's parents who have household registration in the ROC); (the applicant who is the minor who has restored his/her nationality of the ROC may apply for concurrently restoring their nationality of the ROC or having already acquired the alien permanent resident certificate is exempted from attaching the certificate).

Please attach any of the following documents.

(1) Proof of domestic income, tax payment, personal property, or real estate ownership in the territory of the R.O.C. (For those who issue the "Letter of Authorization for Investigation of Income and Property", the household registration office may investigate the data of their income and property of various categories (form 14) from the Fiscal Information Agency of Ministry of Finance or taxing authority.)

(2) Proof of employment by the employer or self-written description of the applicant's job content and income. (form 13)

(3) The certificate of professional occupation, technical personnel or skill test issued by our government agency

(the certificate refers to the one held by any of the spouse, spouse's parents and applicant's parents in the Taiwan area and the certificate holder shall present a certificate of security which can secure the applicant's living needs in the ROC)

(4) Other documents that can prove the applicant is able to be self-reliant.

<p>備註 Remarks</p>	<p>1、Documents required in accordance with these Rules are produced or verified by a foreign embassy, consulate or authorized representative agency stationed in the ROC, verification by MOFA is required. If they are produced abroad, verification/certification by an Overseas Mission, as well as re-verified by MOFA, will also be required. A review by MOFA may be waived if the application has been filed with a Mission Abroad in accordance with Paragraph 3 or Paragraph 4 of Article 2 for approval by the MOI on behalf of MOFA. If the documents referred to in</p>

the preceding Paragraph are in a foreign language, the Chinese translation of the documents, verified by MOFA and Overseas Mission and re-verified by MOFA or a public notary in the ROC, shall also be submitted

2、According to the Name Act, those who restore their nationality shall use their Chinese name adopted when they restored their loss of ROC nationality.

3、The flowchart for those who once had household registration but lost their ROC nationality to apply for restoration of ROC nationality and household registration:

Resident visa (Mission Abroad) → Alien Resident Certificate or Alien Permanent Resident Certificate (National Immigration Agency of MOI) → Nationality Restoration (Apply to the household registration office for transferring to MOI for permit) → Permanent Residence Application from those who have not gone abroad after nationality restoration (National Immigration Agency of MOI. It may be submitted with the restoration to the Household Registration Office); those who have gone abroad shall apply for ROC passport or Entry Permit (applied to Mission Abroad) and shall enter Taiwan with the passport or the entry permit → Application for household registration and National ID card (household registration office)

4、After applying for restoration of ROC nationality, if those who have never had household registration in Taiwan and have lost their ROC nationality plan to apply for household registration and request national ID card, they shall follow Article 15 of the Household Registration Act to apply to the National Immigration Agency of ROC for approval of permanent residence. Please contact National Immigration Agency of MOI at tel. No. 02-23889393 for permanent residence related questions.

※ After nationality restoration, if the foreign national has household registration in Taiwan and is of military age (start from Jan. 1 of the year following the year that they reach 18 years of age and decommission on Dec. 31 of the year they reach 36 years of age), he shall fulfill his military service obligation by law. Please directly contact the office of the township, city or district at the initial household registration place.

※ After initial household registration in Taiwan, if the foreign male applying for nationality naturalization is in the military service ages (from Jan. 1 of the year following the year that the applicant reaches 18 years of age until Dec. 31 of the year that the applicant reaches the age of

36), they shall fulfill the military service duties by law. For the military service related questions, please directly contact the township (city, district) office at the place where the initial household registration was made for details.

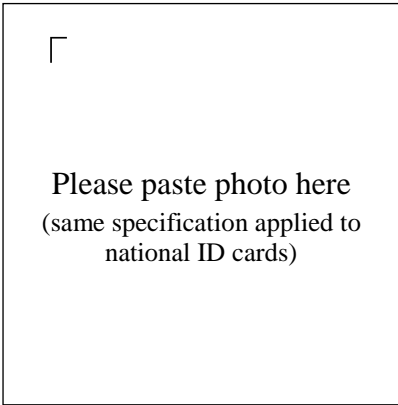
