Application item	II.Revocation of nationality
Application reason	Loss of ROC nationality and no acquisition of a foreign nationality
Governing law	1、Article 14 of the Nationality Act. 2、Articles 2, 14, 17 and 18 of the Enforcement Rules of the Nationality Act. 3、Charge Standards for Nationality Fees
Competent authorities	1、The applicant living locally may file the application in person with his or her residence household registration office, and household registration office will transfer the application to MOI via municipal, county (city) government for approval. 2、Applicant who resides in a foreign country may file an application in person with a ROC Mission Abroad or the agency or private group set up, designated or commissioned by the Executive Yuan in Hong Kong and Macao. The application shall then be transferred through MOFA to the MOI for approval.
Document required	Documents required to be submitted by the applicant 1、Application form for the revocation of Nationality (Form 5) (1)Domestic applicants shall confirm the correctness of the application printed by the household registration office, followed by signing or affixing their seal on the application. (2)Foreign applicants shall fill out the application form for the loss of nationality and sign or affix their seal on the application in person. (3) Application is the minor,Parents shall sign or affix their seal on the application. In the event that the minor's rights and obligations are individually exercised and assumed by either father or mother, the certificate for individual exercise of the custodial rights shall be submitted, in which the father or mother exercising the custodial rights of the minor shall sign and affix their seal on the application. If there is any guardian, the custody certificate shall be submitted, in which the guardian shall sign on the application. If the number of the guardians is more than one, all of the guardians shall sign or affix their seals on the application. 2、Identification certificates. 3、Real copy certificate of loss nationality. The original of the permit certificate for nationality loss shall be returned to MOI. In the event that the permit certificate of nationality loss is damaged or extinguished, the applicant shall concurrently apply for replacement or reissuance of the permit certificate of nationality loss when applying for revocation of nationality loss, and attach the "application for replacement or reissuance of the permit certificate nationality loss" (form 8), for which the applicant is not required to pay the certificate

	<p>replacement (reissuance) fee and MOI is also not required to replace (reissue) the permit certificate of nationality loss to the applicant.</p> <p>4、The application overruled or approval of application withdrawal issued by the foreign government where the applicant originally planned to acquire the nationality or other certificates relating to the applicant's failure to acquire the nationality of the country in question. (please refer to Remarks 1 for the details of document verification)</p> <p>5、If the application is a minor ,should submit agreement of Legal representative ( form10 )</p> <p>6、One full-face bareheaded color photo taken within the last two years (same specification applied to National ID cards and with the applicant's name in hand writing on the back).</p> <p>The documents checked by the Household registration office for the applicant</p> <p>1、Applicant has household registration records, the household registration office shall check the initial household registration or loss nationality record for the applicant.</p> <p>2、The list of loss nationality .</p>
備註 Remarks	<p>1、<b>If the document is produced abroad, it shall be verified by ROC's Mission Abroad and re-verified by our Ministry of Foreign Affairs; if the document is produced or verified by a foreign embassy, consulate or authorized representative agency stationed in Taiwan, it shall be verified by the Ministry of Foreign Affairs. However, no re-verification from the Ministry of Foreign Affairs is required if the document is applied to a ROC's Mission Abroad, transferred by the Ministry of Foreign Affairs and permitted by MOI. If the document is in a foreign language, the Chinese translation verified by the Mission Abroad and re-verified by the Ministry of Foreign Affairs or certified by a public notary shall be submitted.</b></p> <p>2、For overseas ROC nationals who have (had) household registration in Taiwan, the applicant shall literally fill their local household address in the application. Those who have not had any household registration in the ROC and file the application abroad, the competent authority (i.e. ROC's Mission Abroad) shall affix the "no household registration" stamp on the application.</p> <p>※For nationality alteration application cases, please go to the home page of the website of the Dept. of Household Registration, MOI at <a href="https://www.ris.gov.tw/">https://www.ris.gov.tw/</a> and click online application services – "nationality case progress inquiry" operation to inquire the progress of the applied case.</p> <p>※The list of documents as required for application for nationality alteration is merely for information.
