  For those overseas ROC nationals who have (had) household registration in Taiwan, the applicant shall concurrently attach the application for revocation of household registration when applying for the loss of ROC nationality. The applicant shall sign and affix his or her seal on the application in person and turn in his or her national ID card for cancellation. After MOI's permit for the loss of ROC nationality, the application for revocation of household registration will be sent to the applicant's residence household registration office and the application shall be processed in accordance with Articles 24 and 62 of the Household Registration Act.
- 5 For ROC overseas male national as defined by the proviso of Subparagraph 1 of Article 12 of the Nationality Act, the applicant shall submit any of the following documents:
  - (1) Valid ROC passport with endorsement of the overseas Chinese status
  - (2) Overseas compatriot identity certificate for conscription.
- 6 Those who have yet to complete the assistantship registration in Taiwan shall attach the certificate effectively established for the assistantship declaration and meeting the requirement of the ROC or foreign laws.(please refer to Remarks 1 for the details of document verification)
- 7 A letter of consent from the assistant. (form10)
- One full-face bareheaded color photo taken within the last two years (same specification applied to National ID cards and with the applicant's name in hand writing on the back).
- 7 The certificate fee is NT\$1,200 (payment must be remitted via a postal money order, on which the recipient is indicated as the Ministry of the Interior). The fee for the overseas application is US\$47 per piece (or US\$60 clean bill). The fee for the application from Japan is ¥5,500 per piece (or ¥6,300 clean bill) (As of June 11, 2018, the receipt of the payment for the nationality certificate fee by the clean bill has been suspended, for which please refer to remarks 4 for the details).

The documents checked by the Household registration office for the applicant

1 • The criminal record covering the period of the residence in the ROC.

- 2 The initial household registration and current or final household registration record checked by the household registration office for the applicant who has (had) household registration in the ROC.
- 3 For the applicant who is a male ROC national under the military service age and has household registration in Taiwan, the household registration office may check the household registration record stating the military service data for the applicant. If the military service data are not stated in the household registration record, the household registration office will check with the township (city, district) office at the place where the concerned person's household is registered.
- 4 For the applicant who is an overseas male ROC national under the circumstance defined by the proviso of Subparagraph 1 of Article 12 of the Nationality Act, the household registration office may check the applicant's household registration record stating the overseas relocation date and the entry and exit dates for the applicant.
- 5 Applicant already complete the registration for the assistantship registration in Taiwan, checked by the household registration office for the applicant who has (had) household registration for the assistantship registration.
- 6 For those who put a check in the box of the application to "authorize the household registration office to conduct the check", the household registration office (unit) may check relevant no non-payment tax certificates for them.

## 備註 Remarks

- 1 \ If the document is produced abroad, it shall be verified by ROC's Mission Abroad and re-verified by our Ministry of Foreign Affairs; if the document is produced or verified by a foreign embassy, consulate or authorized representative agency stationed in Taiwan, it shall be verified by the Ministry of Foreign Affairs. However, no re-verification from the Ministry of Foreign Affairs is required if the document is applied to a ROC's Mission Abroad, transferred by the Ministry of Foreign Affairs and permitted by MOI. If the document is in a foreign language, the Chinese translation verified by the Mission Abroad and re-verified by the Ministry of Foreign Affairs or certified by a public notary shall be submitted.
- 2 For overseas ROC nationals who have (had) household registration in Taiwan, the applicant shall literally fill their local household address in the application. Those who have not had any household registration in the ROC and file the application abroad, the competent authority (i.e. ROC's Mission Abroad) shall affix the "no household registration" stamp on the application.
- 3 · Applicants who have yet to acquire the nationality of another country but want to apply for the loss of ROC nationality in Taiwan shall check with the Ministry of Foreign Affairs to confirm if they can apply for a limited validity (one and a half years) passport before applying for the loss of ROC nationality, which will facilitate their exit from our country after losing their nationality. If they are not eligible for the application, they shall return to their overseas residence and apply to a ROC Mission Abroad locally for the loss of their nationality (After being permitted by MOI for the loss of the

applicant's ROC nationality, the Ministry of Foreign Affairs will immediately revoke the applicant's ROC passport. If this is the case the applicant will have to re-apply for a passport before being allowed to leave our country. According to Subparagraph 3 of Paragraph 1 of Article 11 of the Regulations for Application and Issuance of Passports, the applicants who have yet to acquire the nationality of another country after losing their ROC nationality shall attach the certificate of the loss of nationality, two photos for the use of passport and the relevant documents proving that they have yet to acquire the nationality of another country, e.g. the resident certificate or resident visa of another country, to apply to the Ministry of Foreign Affairs for a limited validity (one and a half years) passport and then leave our country with the passport).

- 4 To reinforce the anti-money laundering operation, currently, banks shall open a dedicated account to purchase or collect clean bills. However, it will take one month to clear the account's check with a foreign bank before account entry of the amount, which does not meet the stipulated deadline for putting the amount in treasury. Thus, as of June 11, 2018, the receipt of the payment for the nationality certificate fee by the clean bill has been suspended.




